The Data controller

The data manager of your personal data (the legal entity that makes a decision on the purpose and methods of processing your personal data) is the Plomba Kft., whose registered office is: 1136 Budapest, Hegedűs Gyula u. 45-47. The provision of personal data is voluntary, but indispensable for the conclusion of the purchase contract.

Provision of information on the processing of personal data

Purpose of data request and processing

We request and process your personal data because they are essential for the execution of the contract with you, i.e. for the purpose of the sale, including the following:

- Customer registration in the order system, for administrative purposes.
- To the competent tax authority for tax purposes.
- To the competent tax authority for invoicing purposes.
- To the bank card company for payment purposes.
- For delivery purposes to the postal service provider.
- For the purpose of investigating complaints and complaints.
- For statistical purposes, in which case the data manager's legally justified purpose is to have information about the statistics of the activities carried out, which provides an opportunity to further develop the products and the webshop.

To whom the data may reach

Your personal data may be forwarded to other legal entities that process your data on their own behalf, such as e.g. among others:

- Legal entities engaged in postal or courier service activities;
- Bank card companies for the purpose of conducting payment transactions;
- Banks for the purpose of reclaiming services taken without a legal basis;
- State bodies or other legal entities authorized by law, for the purpose of implementing our obligations (State Treasury, Tax Office, Executive bodies, etc.);
- Persons and companies operating our IT systems necessary for the continuation of business (hosting companies, providers of IT services);
- Organizations that provide legal advice, accounting, taxation or consulting for us.

Duration of data storage

The storage of your personal data continues until the contractual obligation (performance of the service) exists, and continues thereafter as follows:

- Due to the requirements arising from legal regulations, especially regarding accounting, invoicing, etc. for the duration of the document retention obligation;
- Documents related to warranty and complaints are stored for 1 year after the end of the warranty period or the resolution of the complaint;

Rights related to data management

You have the right to access your own data, the right to modify, delete, restrict processing and transfer data, the right to object and the right to withdraw your consent to data processing at any time, regardless of the existence of the legal basis on which the data processing is based on the consent continued before its withdrawal (if the given data processing is based on consent).

In addition to the above, in the event that you believe that our data management violates legal provisions, you have the right to file a complaint with the data management supervisory body.

Automatic data management (customer profile creation)

Your personal data is processed automatically (including the customer profile creation form), but this does not have any legal consequences for you and does not affect your situation.

Other provisions

In matters not regulated in this GDPR policy, the Hungarian Civil Code is the governing Act.

In the event of any legal dispute, the Hungarian equivalent of this GDPR policy shall govern, the parties stipulate the application of Hungarian law, and acknowledge the jurisdiction of the Buda Central District Court in their disputes.
